RE: MR. D. CLINT STABLES, SUPERINTENDENT OF SCHOOLS

Mr. Stables reported their will be a 2 hr. delay in school tomorrow due to the weather.

Mr. Stables then stated the drop out rate reported was received and it was not pleasant. He said they will be looking at 22 former students to find out why they did not graduate in four years and what they are doing now. He continued on and said that it doesn't just affect high school students but also Elementary and Middle School students if they are held back 1 year. Supervisor Tomlin commented that if the attendance is being checked then it doesn't count against the system.

Mr. Stables reported his concerns with the composite index that has gone up from .7355 to .80. Mr. Stables went on to say they have been working on a projected estimate of loss of money for the County due to the index changing and estimates of a loss about \$710,000.00 is what we have projected. Also there will be a loss of stimulus funds in the amount of \$577,879.00. The sales tax drop is \$116,000.00 and the VRS increase of 4%, totals \$480,000.00. Mr. Stables reported a total decrease of approximately 1.5 million dollars for the next school year. He added this is the worst budget in years.

Chairman Jett questioned the stimulus money saying he was thought the money would be divided up between 2 years.

Mr. Stables said he was going to look at more information and seek public input and what options we need to explore to balance out.

Other concerns with the school, Mr. Stables reported the towers on the new schools are leaking and the contractors are working on fixing this problem. Supervisor Haynie expressed his concerns with the problems that are occurring with the new school and said he thought the contractors were dragging their feet. Mr. Stables stated they are still holding enough money in order to get this all straight. Supervisor Tomlin said this is ridiculous and shows no pride in workmanship. Supervisor Tomlin asked if they have signed off on substantial completion. Mr. Stables said they have been requesting it, but it has not been signed off and we are withholding a substantial amount of money. Supervisor Haynie stated that this type of workmanship was a waste of taxpayer's dollars.

Supervisor Self suggested during sporting events to get someone to direct traffic off of the grass.

Supervisor Long informed Mr. Stables that screws were coming out of the bleachers.

Supervisor Tomlin questioned whether there was an American flag is in the Auditorium? Mr. Stables stated that yes there was but it had been taken out for an event in the gymnasium.

Chairman Jett stated he was concerned about the report card problem that the students had with getting them. It took entirely too long.

**RESOLUTION
AMENDMENT TO NORTHERN NECK REGIONAL ENTERPRISE ZONE**

WHEREAS, the Counties of Lancaster, Northumberland, Richmond and Westmoreland, and the Towns of Kilmarnock and Warsaw (known as the localities) comprise the Northern Neck Regional Enterprise Zone; and,

WHEREAS, the localities have designated and authorized the Northern Neck Planning District Commission to serve as EZ Program Administrator and to carry out all program administration and reporting requirements on their behalf; and,

WHEREAS, Westmoreland County and the Town of Warsaw propose to amend their enterprise zone areas to include additional property as outlined on Attachment 1 & 2 to this resolution; and,

WHEREAS, Westmoreland County and the Town of Warsaw have conducted the required public hearings and adopted resolutions endorsing and authorizing the proposed amendment;

NOW, THEREFORE, BE IT RESOLVED THAT the Northumberland County Board of Supervisors hereby endorses and approves of the proposed amendment to the Northern Neck Regional Enterprise Zone and authorizes the County Administrator to execute FORM EZ-2-JA.

RE: DECISION TO HIRE SPRINGSTED INCORPORATED TO DO FIRE STUDY FOR THE COUNTY

Mr. Eades informed the Board that he had met with both Fire Chiefs and Chairman Jett on the Fire Study Proposals that were received. Mr. Eades stated that they unanumously decided to hire Springsted Inc. to complete a fire study for the entire county and at the existing fire stations to see if they are adequate. The cost for the proposal is \$11,580.00 and \$1,000.00 for expenses.

Zoning Administrator, W.H. Shirley described the request for the conditional use and stated he received one comment that was just an objective statement.

Ms. Marl stated she plans on putting retired horses there and no breeding will take place. She is requesting the goats as a hobby.

Mr. Lee Allain said at first he was unsure about the request but after talking with Ms. Marl, he thought this is okay.

1. The permit will be issued upon receipt of a nutrient management plan that includes storage and handling of animal waste and a rotational grazing plan. Both plans must comply with all state and federal guidelines and be approved by the Northern Neck Soil and Water Conservation District;
2. Adequate fencing that provides for a minimum of 1.5 acres of pasture or paddock area per horse; and,
3. You will be limited to keeping 8 horses and 18 goats on the property.
