Notice of Public Hearing

Notice is hereby given pursuant to Chapter 11, 15.2-2204 of the Code of Virginia as amended that the Northumberland County Board of Supervisors will hold a public hearing on **June 12, 2014 at 7:00 p.m.** in the Northumberland County Courts Building (220 Judicial Pl) at Heathsville in order to consider the following:

1. An amendment to the Northumberland County Zoning Ordinance Chapter 148 Article I, Section 148-3; Definitions and word Usage, to:
 - a. Delete the following terms and associated definitions: "Boarding House" and "Motel, Cabin, or Motor Lodge".
 - b. Modify the following definitions: "Bed and Breakfast", "Single-Unit Dwelling", "Hotel/Motel", and "Tourist Home".
 - c. Add the following terms and associated definitions: "Transient" and "Vacation Home Rental".
2. An amendment to the Northumberland County Zoning Ordinance Chapter 148 Article I, Section 148-5; Usages, to:
 - a. Remove uses: "Boarding House" and "Motel, Cabin, or Motor Lodge".
 - b. Modify use: "Hotel" to read "Hotel/Motel".
 - c. An amendment to the Northumberland County Zoning Ordinance Chapter 148 Article I, Section 148-5; Usages for the Agricultural (A-1), Conservation (C-1), Residential General (R-1), Residential Waterfront (R-2), Residential Recreational (R-4) Districts, to include "Vacation Home Rental" as a Permitted Use and to include "Vacation Home Rental" as a Conditional Use in the Business General (B-1) District.
3. An amendment to the Northumberland County Zoning Ordinance Chapter 148 Article XIV, Section 148-155, to list requirements to be met in order to operate a "Vacation Home Rental"
4. The Board will also consider recommendations made by the Planning Commission on the language above from their May 2014 meeting.
