

NOTICE OF PUBLIC HEARING

Notice is hereby given pursuant to Section 28.2-1302 of the Code of Virginia, that the Northumberland County Wetlands Board, at a meeting in the Board of Supervisors Room of the Old Courthouse in Heathsville, Virginia, on **Tuesday, October 13, 2009, commencing at 7:30 P.M.**, will consider the following applications for wetland and/or coastal primary sand dune and beach permits:

- 1) Request by Carl Christiansen, et al (V.M.R.C. #09-1275) to install 165 linear feet of riprap revetment along the shoreline of Bells Creek and 325 East Fairway Drive.
- 2) Request by William F., III and Christine C. Dunnington (V.M.R.C. #09-1223) to remove 2 existing deteriorated groins and install one 50' vinyl groin from the shoreline of the Potomac River and 1365 Shore Lane.
- 3) Request by Patricia L. Henderson (V.M.R.C. #09-1209) to replace an existing groin with a 78' low-profile groin from the shoreline of the Chesapeake Bay and 2 Beach Road.
- 4) Request by Fox Run Farm, Inc., Thomas Keeling, owner (V.M.R.C. #09-1232) to install 150 linear feet of riprap revetment along the shoreline of Bridge Creek and 346 Laurel Lane.
- 5) Request by George Lichtenburger (V.M.R.C. #09-1182) to construct 545 linear feet, including return walls, of timber bulkhead along the shorelines of the Coan River, Mill Creek and 872 Bundick Road.
- 6) Request by James S. and Sheryl Loop (V.M.R.C. #09-1302) to remove an existing deteriorated groin and construct a low-profile timber groin 48' from MHW from the shoreline of the Potomac River and 165 Cabin Lane.
- 7) Request by Patrick D. McMullen (V.M.R.C. #09-1291) to construct 96 linear feet, including return walls, of timber bulkhead along the shorelines of Cod Creek and 205 Trumps Court.
- 8) Request by Patricia C. Ramey (V.M.R.C. #09-1274) to install 62 linear feet of riprap revetment along the shoreline of Lawrence Cove and 371 Lawrence Cove Lane.
- 9) Request by Timothy Ward (V.M.R.C. #09-1292) to install 93 linear feet of riprap revetment along the shoreline of Dividing Creek and 433 Whittaker Lane.

The applications requesting the proposed permits are on file in the Office of Building and Zoning at the Old Courthouse in Heathsville, VA, where all interested parties may view and inspect the projects.
