

NOTICE OF PUBLIC HEARING

Notice is hereby given pursuant to Section 28.2-1302 of the Code of Virginia, that the Northumberland County Wetlands Board, at a meeting in the Board of Supervisors Room of the Old Courthouse in Heathsville, Virginia, on **Tuesday, July 12, 2011, commencing at 7:30 P.M.**, will consider the following applications for wetland and/or coastal primary sand dune and beach permits:

- 1) Request by Mason Beazley (V.M.R.C. #11-0858) to install 70 linear feet of marsh toe stabilization along the shoreline of Henrys Creek and 4394 Bluff Point Road.
- 2) Request by Robert W. Chewing (V.M.R.C. #11-0860) to install one (1) 48 linear foot rock groin with a 10' spur and install ten (10) rock groins each 24 feet in length from the shoreline of the Great Wicomico River and 364 Wicomico View Lane.
- 3) Request by Arthur D. Gilbert (V.M.R.C. # 11-0749) to install 250 linear feet of riprap revetment along the shoreline of Cole's Cove and 650 Blackwells Wharf Road.
- 4) Request by Indianola Farm, LLC (V.M.R.C. #11-0744) to install 350 linear feet of riprap revetment along the shoreline of Hull Creek and 255 Candy Point Road.
- 5) Request by Mundy Point and Watts Point Farms, Inc. (V.M.R.C. #11-0891) to install 1,025 linear feet of riprap revetment and install 204 linear feet of riprap sill along the shoreline of Mill Creek and Drum Cove and 2492 Mundy Point Road..
- 6) Request by Stanley D. and Judith Ann Rasberry (V.M.R.C. #11-0890) to install 116 linear feet of riprap revetment along the shoreline of Glebe Creek and 1255 Glebe Road.
- 7) Request by Morris B. Taylor (V.M.R.C. #11-0830) to construct 387 linear feet of timber bulkhead two feet channelward of an existing deteriorated bulkhead along the shoreline of Whays Creek and 263 Whays View Lane.
