

NOTICE OF PUBLIC HEARING

Notice is hereby given pursuant to Section 28.2-1302 of the Code of Virginia, that the Northumberland County Wetlands Board, at a meeting in the Board of Supervisors Room of the Old Courthouse in Heathsville, Virginia, on **Tuesday, August 9, 2011, commencing at 7:30 P.M.**, will consider the following applications for wetland and/or coastal primary sand dune and beach permits:

- 1) Request by Matthew R. Ball (V.M.R.C. #11-0983) to install 88 linear feet of riprap revetment along the shoreline of the Little Wicomico River and Tax Map Parcel #28C-(4)-233, on Sherwood Drive in Sherwood Forest Subdivision.
- 2) Request by Theodore and Mary Barna (V.M.R.C. #11-1030) to install 27 linear feet of riprap revetment along the shoreline of Sloop Creek and 47 Smith Point Circle.
- 3) Request by David W. Boldridge (V.M.R.C. #11-1015) to install 114 linear feet of riprap revetment channelward of an existing bulkhead along the shoreline of Ingram Bay and 98 Ingram View Lane.
- 4) Request by Gustave J. Comeyne, Jr. (V.M.R.C. #11-1008) to install 220 linear feet of riprap revetment along the shoreline of Glebe Creek and 571 Old Farm Lane.
- 5) Request by Monte B. Lake (V.M.R.C. #11-1046) to install 225 linear feet of riprap revetment along the shoreline of Mill Creek and 1452 Mundy Point Road.
- 6) Request by Marie Pulzone (V.M.R.C. #11-1007) to remove an existing deteriorating bulkhead and install 190 linear feet of bulkhead in the same footprint and install 25 linear feet of new bulkhead along the shoreline of Glebe Creek and 467 Old Farm Lane.
- 7) Request by Cynthia C. Taylor (V.M.R.C. #11-1038) to install 20 linear feet of riprap revetment along the shoreline of Cockrells Creek and 2740 Fleeton Road.

The applications requesting the proposed permits are on file in the Office of Building and Zoning at the Old Courthouse in Heathsville, VA, where all interested parties may view and inspect the projects.
