RE: VDOT UPDATES-WORKSESSION 6 YEAR PLAN

Mr. Steve McKeever and Mr. Carter White were present for the meeting representing VDOT. They presented to the Board the proposed Six-Year Improvement Program. The public hearing for the 6 Year Plan will be held next month, May 10 at the regular Board of Supervisors meeting. Mr. McKeever stated that this is just for roads within the secondary system. He then presented the roads on the list including Rt. 613, Millwood Ln as well as Rt. 739 Driftwood Trail.

Supervisor Self questioned Rt. 200 at the intersection. Mr. McKeever stated that the right-of-way utilities would be costly. Chairman Jett asked if the Rt. 360 highway through where the work was done on Academic Lane is still scheduled to be done. He said it was still on track. Supervisor Self noted a deep drop there by that road and it possibly would need a guardrail.

Mr. McKeever stated that there is possibility that another road could be added to the secondary plan and introduced the idea of Madge Pt. Road that needs some improvement and would cost in the \$150,000 range. The improvement would be about a half mile.

Luttrell stated that he had received a request by email for a speed study done on Blackwell's Wharf Road. It is currently 40 mph and they felt it needed to be lowered because of the restaurant that is about to open at Horn Harbor. No action was taken.

RE: DR. HOLLY WARGO, SUPERINTENDENT OF SCHOOLS

Dr. Wargo came today to give an update on the school activities including all of the student winners going to the area state bowl. She then gave important upcoming dates and the principals reports from each school.

Ms. Donna Booth, Director of Finance, stated that the current average daily enrollment is 1243 in grades K-12. She then noted the security grant they received and what the money was used for.

Dr. Wargo mentioned to the board that she would like to see an additional School Resource Officer at the Middle/High School.

RE: MS. KATHY VESLEY, CEO/PRESIDENT – BAY AGING

Ms. Vessley thanked the Board for their support. She provided a handout to the Board describing how they contribute to our County and the services that they provide. She stated they are requesting to be level funded this year for the budget.

A Bay Transit representative also came today and thanked the Board for the 18 years of support. They have provided over 8500 rides and 50% of those rides are people going to and from work. He then described the Freedom rides they provide in which is federally funded through a grant. He noted that funds are limited for the Freedom Rides so they have to limit them. He stated they are always needing volunteers.
