RE: DR. HOLLY WARGO, SUPERINTENDENT OF SCHOOLS

Dr. Wargo came today to highlight several school related items including, personnel appointments for 2017-2018 and noted congratulations to Mrs. Theresa Larson on her upcoming retirement as NES Principal. Dr. Wargo informed the Board that NES will be installing a Rock Wall in the gymnasium and especially thanked Teacher Nancy Burgess for all her work on this project. She then gave a sick leave bank annual report. The School board will hold a special meeting on Tuesday, July 25 at 10 a.m. in Lottsburg in order to approve personnel appointments.

Supervisor Long questioned the purchasing of a buses and asked the school board to work hard not to get behind on buses to keep the rotation going.

RE: DR. WILL STALLINGS, M.D. – RAPPAHANNOCK GENERAL HOSPITAL

Dr. Stallings stated he was born and raised in Reedville and started his medical career as a member of the Northumberland County Rescue Squad. He said he came today to this meeting to discuss the changes with Rappahannock General Hospital and the direction the hospital is going in. He wanted to clear up some rumors as well, including, they are not closing and they are not becoming a nursing home. The changes revolve in the Intensive Care Unit. He said these changes have been transitioning over the years and now that they are no longer privately owned it is no longer feasible to have the ICU. He did say that we are fortunate to have Bon Secours here and it wasn't a sudden decision. He then noted the surgery schedule change.

Dr. Stallings gave his contact information and stressed that they have a high level of concern and they are not going away. They will continue to provide care and stated they are needing more space to expand.

Supervisor Haynie asked about the cardiac care. Dr. Stallings stated that cardiac care is a priority for them and noted that Dr. Hawkins office is located next to the YMCA. He explained the upfront treatment that will be provided and then the patient will then be evaluated and possibly may end up getting transferred.

Mr. Bruce Craig asked if there was a plan for an Urgent Care facility in the future. Dr. Stallings said that the problem now is the number of providers they have access to. They hope to have more in the future to be able to support such a facility.

Mr. Lee Allain stated that the Bon Secours office here in Heathsville is a local concern. Dr. Stallings expressed the problem with the number of providers in the area.

Ms. Ginny Estelle stated she feels that they are putting more emphases on the EMS workers (prior to arriving at the hospital). Dr. Stalling's said all of that is the same including the training EMS providers receive.

Supervisor Tomlin added that after hearing Dr. Stalling speak on different occasions that he is emotionally concerned and cares about the community.

Article III: County Owned/Managed Boat Landings

§ 38-5 Regulations for use of County Managed Boat Landings.

The following regulations for use of all Northumberland County owned or managed Boat Landings are hereby adopted:

- A. No loitering and persons using this area must not trespass on adjoining properties.
- B. No use of alcohol, drugs, or profanity of any kind will be allowed.
- C. No excessive or loud music or noise.
- D. Persons using this area shall properly dispose of their trash.
- E. No swimming, sunbathing, or nudity will be allowed.
- F. No vessels to be moored to the pier or any other object on County owned property other than for the purposes of unloading or loading a vessel. There shall be no overnight mooring of vessels.
- G. No fires are allowed.

§ 38-6 Violation and penalties.

Any person who violates §38-5A through §38-5G of this chapter shall, upon conviction, be punished as a violation of this chapter at \$100 for the first violation and \$250 for the second offense.
