#### RE: VIRGINIA DEPARTMENT OF TRANSPORTATION, MR. CARTER WHITE

Mr. White came before the board today for a work-session to review the proposed plan for the secondary road, six-year plan for the years 2018-2023. This will also include the FY 18 budget for the secondary system. He noted this does not include snow removal and maintenance. Mr. White also explained the funding sources that are available. The secondary system construction program list includes projects such as, Rte 360/Academic Ln. He said they didn't use funds from any of the three sources but has to list it because it is federal funded. He hopes this will start about May 15, 2017 but will not affect the graduation ceremony at the school in June. He also hopes to finish up this project around October 23<sup>rd</sup>.

He also stated he will need to get with Mr. Tadlock on setting up a meeting on how to spend left over project money from Rt. 604 and Rt. 607. Supervisor Tomlin asked if a culvert is needed on Fleeton Road. Mr. White said this has been researched and this project was eliminated because it would be a significant impact on the traffic on that road and they don't feel it would be appropriate to do this because of the undertaking and currently the pipes are functioning. Supervisor Long asked if he had a list of suggestions. He said he would be getting with County Administrator Tadlock.

Supervisor Long asked about the boat ramp sign that is gone from Gardy's Mill Pond.

Supervisor Haynie asked about the steps VDOT takes to determine if they will be milling or paving. Mr. White explained the process with the pavement rating as well as other variables. Supervisor Haynie then questioned the cost per mile to mill the roads. Mr. White explained that this area is one of the highest in the State to mill because there is only one company around that does this and the rock is at a minimal.

Supervisor Tomlin asked about the Downing Bridge as far as the problems that motorist have while they are working on it. Mr. White said they are evaluating this issue and are going to try to do the work at nights or switch to an automatic flagging device.

The public hearing will be advertised by the Virginia Department of Transportation for the Six-Year plan scheduled for next month, June 8, 2017 at 7 p.m.

## RE: MR. ED GRAY, FLOTILLA COMMANDER, USCG AUXILIARY- NATIONAL SAFE BOATING WEEK PROCLAMATION

#### **PROCLAMATION**

Americans are increasingly heading to the water for recreation and relaxation as the opportunities for

on-the-water activities increase each year. With this growth comes additional responsibility. It is essential that both novice and experienced boaters alike learn and practice safe boating habits, wear a life jacket, and have aboard essential safety equipment. This year's theme of the Boating Safety Campaign, "Wear It". Always Wear A Life Jacket", recognizes that boating safety begins long before the boat leaves the dock. Studies show that boaters who take a boating course are 4-5 times less likely to have a boating accident and 80 percent of the people who died in boating accidents were not wearing life jackets.

Whereas, the number of boats registered in Northumberland County is 5,537, and even more boats visit our area waters each summer,

Whereas, hundreds of lives could be saved each year by the wearing of life jackets and the life jackets of today are more comfortable, more attractive, and wearable than styles of past years,

Whereas, the law requires that wearable life jackets be carried for each person on board the boat - and little effort is needed to wear those life jackets,

Whereas, boating courses are readily available from the Coast Guard Auxiliary throughout the primary boating season,

Now, Therefore it be resolved, that, the Northumberland County Board of Supervisors, do hereby support the goals of the National Safe Boating Campaign and proclaim May 20th through May 26th as "Safe Boating Week" and the start of the year round effort to promote safe boating in area waters.

# PUBLIC HEARING 7 P.M.

RE: PUBLIC HEARING REQUEST BY THOMAS AND SHARON WRIGHTSON, OWNER, FOR A CONDITIONAL USE PERMIT TO ALLOW PERMANENT STORAGE OF A MOBILE HOME. THE PROPERTY IS LOCATED AT 697 MUNDY POINT ROAD.

Zoning Administrator Philip Marston described the request for a conditional use permit to allow a permanent storage of a mobile home at the residence located at 697 Mundy Point Road.

Mr. Wrightson said this mobile unit is not a home, it is a 24' by 36',old Fredericksburg school building and it is for storage work area only and not living space.

Supervisor Self questioned the trailer location being different on the drawing from what was advertised.

#### **Public Hearing Open**

Ms. Rosalie Coultrip stated that having this mobile unit is not in character with the rest of the residents of the area. She asked if the unit is for him to make crab pots and if so then this is a business. She said if this is approved she hopes there will be strict, clear use of the building and no business. She wants it to be kept neat and in an orderly fashion. She said she is opposed to this request especially if this is a business.

Mr. Warren Woolly of 775 Mundy Point Road expressed his concern with the primary events. He gave an example such as during the fall of 2016 when hunters gathered at this location and proceeded to trespass on other property hunting. He also noted he felt it was a type of hunt club.

#### **Public Hearing Closed**

Mr. Wrightson stated to the board that part time he makes crab pots for Jett's Hardware and this is a place he can build inside. He is 65 years old and continued to say he is not associated with some of them boys he used to be associated with and it is no hunt club. He said he also makes custom jewelry and he stores pots but takes the finished products elsewhere and nothing is sold on the property.

Supervisor Self suggested carrying over this request because the conditions may change and asked Mr. Wrightson to put 4 stakes out where the mobile unit will be located. Supervisor Self asked what kind of condition the mobile home was in. Mr. Wrightson said he will be doing some minor repairs to the building.

Tomlin, the board voted to carry over the request and asked the owner, Mr. Wrightson, to place stakes out where the mobile unit will be moved to and to contact Mr. Marston to let him know when he has placed the stakes so that it can be revisited.

RE: PUBLIC HEARING REQUEST BY DONALD WALTROUS, OWNER, FOR A CONDITIONAL USE PERMIT IN ORDER TO ALLOW FARMING WITH LIVESTOCK ON PROPERTY ZONED R-2, RESIDENTIAL WATERFRONT. THE PROPERTY IS LOCATED AT 2115 MOB NECK ROAD.

Zoning Administrator Marston described the request to allow farming with livestock on property zoned R-2, residential waterfront. This property is located at 2115 Mob Neck Road.

Mr. Donald Waltrous was present for the hearing and explained that he wanted to clarify "farming with livestock". He said he is not a farmer, he has pets and he has been there close to 10 years. He is in the middle of a family squabble and he is moving his pets to his own personal property. He added that this is his full-time home.

Public Hearing Open

Mrs. Deanna Waltrous stated that their pets are goats, ducks, chickens, and a rescue pig.

Mr. Eliot Levinson stated that his property butts up to the Watrous property and they have nice animals that are pets and he has no issue with this request.

Ms. Bryna Brennah does not have any issues with this and it is a huge amount of property. This is a rural county and it is appropriate to have pets such as chickens.

Ms. Yvonne Swann stated that the animals they have are pets and well loved. This is rural area and there have not been any complaints.

Ms. Bonnie Bryce is a neighbor and the Watrous's are lovely neighbors and the animals are miles from Mob Neck Road.

Ms. Carolyn Plummer stated that they have not had any issues with their neighbor, the Watrous's.

Mr. Scott Watrous stated that he is in opposition to this request and the majority of the owners in Cubit Creek do not have to deal with this issue. He said he strictly opposes this.

Supervisor Tomlin asked how much land does he (Donald Watrous) own? Mr. Donald Watrous said he owns a lot that is 1.13 acres and Scott Watrous owns .91 acres. Serenity Farms LLC is 62 acres which includes a grass runway. Mr. Scott Watrous said he is having problems with the animals on the runway as he needs to land his plane. He then indicated that this is a business with the animals.

Mr. Donald Watrous stated he does not have any intentions to have a business and this is family issue and Scott does not live here and has only come down a few times in the last year. He stated that some of the chickens were given to them by Scott. He did add that the eggs from the chickens are given away.

County Attorney, Matson C. Terry was asked the difference between livestock/farm animals versus pets. Mr. Terry said it is in the "eye of the beholder".

Supervisor Self said he thinks it is a water quality issue and also a private issue and we are not going to take care of a family squabble. Supervisor Tomlin agreed that Northern Neck Soil and Water needed to be notified and give their opinion because of the Chesapeake Bay Act.
