RE: RESOLUTION – MIDDLE PENINSULA DETENTION PROVISION AGREEMENT

County Administrator Tadlock stated that The Merrimac Juvenile Detention Center ("Merrimac") is operated by the Middle Peninsula Juvenile Detention Commission for the Commonwealth of Virginia. It serves both the 9th and the 15th District Court Service Units for a total of 18 localities, including Northumberland County. On January 27, 2017 the Middle Peninsula Juvenile Detention Center Commission unanimously voted to recommend the revised service agreement changes to the respective governing boards. Any changes to the service agreement must be approved by the governing bodies of all eighteen member localities. A similar request was presented for consideration last year and the Northumberland County Board of Supervisors approved the amendments along with other localities, however, one member objected to the obsolete reference to the "per diem" term still present in that version and it did not pass all members.

CONCURRENT RESOLUTION OF THE MIDDLE PENINSULA DETENTION COMMISSION AND ITS MEMBER JURISDICTIONS, AMENDING THE PROVISIONS OF ITS DECEMBER 1994 SERVICE AGREEMENT.

Whereas, the Service Agreement ("Agreement") was signed by the Member Jurisdictions in December 1994 to govern the parties' respective obligations before, during, and after the construction of the Middle Peninsula Detention Center ("Center"); and

Whereas, because the Agreement has been in effect for 23 years, and because the Center has been constructed and placed in service, the Commission and Member Jurisdictions realize that portions of the Agreement are no longer applicable or are no longer efficient; and

Whereas, the Commission and Member Jurisdictions desire to revise the Agreement by

- 1. Replacing the original "per diem" formula with a rolling 5-year member utilization method in order to improve predictability of the Member Jurisdictions' and the Commission's respective annual budget process beginning with Fiscal Year 2018;
- Replacing "Per diem" with "Member Usage Fee" to better represent the new funding method;
- 3. Removing obsolete provisions that applied only during pre-construction and construction of the facility;
- 4. Removing references to King George County, which is no longer a member; and
- 5. Other technical revisions as set out in the amended Agreement attached hereto and incorporated herein.

Whereas, other than as amended hereby, the Agreement as originally adopted remains in effect; now therefore

Be it concurrently resolved, by the Middle Peninsula Juvenile Detention Commission, the Boards of Supervisors of the Counties of Caroline, Charles City, Essex, Gloucester, Hanover, James City, King and Queen, King William, Lancaster, Mathews, Middlesex, New Kent, Northumberland, Richmond, Westmoreland and York, and the Councils of the Cities of Poquoson and Williamsburg, that Agreement adopted by all of them effective December 12, 1994, is amended and readopted as set forth in the attached Agreement.

RE: RENEWAL OF HEALTH INSURANCE WITH LOCAL CHOICE

County Administrator Tadlock stated that we have received information from the Local Choice Group that Administers our health insurance for our County employees. Currently the County pays 100 percent of the Key Advantage 1000 with Comprehensive Dental for each County employee which is \$534.00 a month. We have been informed that rates have gone down this year to \$514 for the Key Advantage 1000 with Comprehensive Dental and will save the County over \$21,000 thousand dollars for the same coverage. The Board needs to consider adoption of the plan resolution prior to April 1st.

RE: RESCUE SQUAD ASSISTANTS FUNDS GRANT APPLIED FOR

County Administrator Tadlock stated that Chief McClure would like to apply for the Rescue Squad assistance fund for the County. The grant is 50/50 match and the deadline is March 15th. The grant is

for equipment and an ambulance. If we don't submit by the March deadline we would have to wait until September to apply.

Supervisor Self asked if there was any reason we should not apply now. Supervisor Tomlin said the budget aspect would be one question and then asked about the mileage estimate on the ambulance we currently have. Supervisor Long asked Mr. Tadlock what he suggests. Mr. Tadlock said he didn't want to leave the County in a bad spot and not have an ambulance that is reliable. A new squad is approximately \$200,000 to 250,000 without equipment. Supervisor Self questioned if we even have a choice at this point, and asked, why wait? Supervisor Tomlin gave information on the equipment that would be in the new squads including the life Pak 15, Lucus 3. He then noted that procedures were not fully discussed on the squads. Supervisor Self said there is no quick fix and thinks we need to go ahead and proceed because the process takes a while and we can have it as a budgeted item.

Mr. Paul Gryskewicz stated that the house was constructed in 1975 and as things happened the house sat there for 30 years untouched. He said he talked with a representative from DEQ about the process and how to proceed. He said he called for an electrical inspection and found out he had to apply for an after the fact permit for the deck. He said there aren't any pictures of the original deck. He is trying to make the property look nice and he didn't know he needed a variance.
