RE: OPENING STATEMENT FROM CHAIRMAN JETT

Chairman Jett opened the meeting saying that he had received concerns about a talk at the Library this evening and in no time did he ever attempt to cancel the event and neither did any of the other board members, he was just passing along citizen's concerns of calls he had received. Supervisor Long thanked Chairman Jett for making the statement.

RE: VIRGINIA DEPARTMENT OF TRANSPORTATION

Mr. Todd VanLandingham reported on the recent snow storm that hit the area and outlined the plan of attack they took to clear the roads. He said the primary roads were the first priority while the secondary roads had a tremendous amount of drifting.

He then thanked everyone for helping out during the storm and added he was happy that everyone worked together.

Mr. VanLandingham stated there are many potholes due to the recent bad weather. He said they are working on them continuously trying to get them patched up. He then addressed some of the drainage issues with which they have been dealing.

Supervisor Self thanked VDOT and said this was definitely a hard snow to push. Supervisor Long asked for the representatives to meet him one day next week to look at a problem on Light Street. Supervisor Tomlin noted potholes in the North Bound Lane of Rt. 200 and Rt. 360. Supervisor Haynie also noted potholes on Firehouse Lane.

Supervisor Tomlin questioned Mr. David Brown about the need for snow fences in the County. During Supervisors Tomlins research, he has noticed that plastic fencing is now being used. Mr. Brown stated he would look into it.

Supervisor Self said he would get in touch with Mr. Brown concerning Rt. 360 turning West.

Mr. Brown updated the board on the project at the end of Academic Lane. He said they are receiving bids for potential construction to start in May.

RE: DR. REBECCA GATES, SUPERINTENDENT OF SCHOOLS

Dr. Gates also talked about the recent snow storm. She thanked Mr. Jett and Mr. Tadlock for the help they gave in trying to clear the bus loop. With the days missed from snow she also gave a new schedule concerning SOL retakes.

Dr. Gates spoke briefly on the upcoming budget. She said they have had a long list of requests and have narrowed it down. She invited the board to discuss the budget with them and boxed dinners will be provided. She also added that a table-top exercise will be done through EMS soon.


RE: 2015 YEAR END REPORT

County Administrator Luttrell Tadlock presented the 2015 year-end report. The complete copy is in the Board of Supervisor Papers for the month.

The Office of Building and Zoning administers various ordinances involving building, zoning, wetlands, etcetera, as well as the planning functions of the County. The following is a compiled list of various requests from the 2015 calendar year, which were processed through this office.

Comparison of Construction Cost:

In 2015, the total estimated cost of construction was \$23,175,770.00 compared to \$32,553,021.78 for 2014. The total estimated cost of construction showed a decrease of approximately -29% from 2014 to 2015.




Figure 2 shows the total number of Single Family Dwellings permitted from 1982 through 2015.

RE: PEMS LETTER RECEIVED

County Administrator Tadlock explained to the Board about the Restructuring of the Peninsulas Emergency Medical Services Prehospital Committees. Under the new structure, the separate prehospital committees will be combined into one EMS Operations Committee. The Board is being asked to select one representative and an alternate to represent Northumberland County and all licensed EMS agencies in the County.

The Board asked for this matter to be discussed by the EMS Team and for them to make a recommendation to the Board.

RE: SCHOOL REVENUE BOND UPDATE

County Administrator Tadlock stated the School Board passed the resolution required to make application for the refunding opportunity through the Virginia Public School Authority. He noted the Board has heard from two potential financial advisor firms that could aid the County in submitting the refunding application. A decision would need to be made tonight with which firm the Board wished to proceed with as the application is due on February 29. Refunding of the bonds could save the County as much as 5 or 6 million over the term of the bond. This total savings is not known yet as the rate will be set at a later date.

Upon motion by James M. Long, duly seconded by Thomas H. Tomlin, the board voted to select Davenport and Company as the Financial Advisor to refinance the 2006 High School/Middle School original school bonds.

Chairman Jett asked Supervisor Long if there were any reasons in particular for selecting Davenport and Company. Supervisor Long stated that he felt that Davenport answered his questions more thoroughly. Supervisor Self said if we use Jim Johnson with Raymond James, then he did the first school bonds but he was fine with either.

WHEREAS, Aqua Virginia currently operates a water system that provide services to several residential communities in Northumberland County, including, Mallard Bay, River's Bend Estates, Bon Harbor, Brown's Store, Burgess, Callao, Chesapeake Bay Estates, Glebe Point, Heathsville, Indian Creek, Lottsburg, Town of Reedville, Wicomico Church and Wicomico Ridge; and

WHEREAS, many of these customers have expressed dissatisfaction with the service they receive from Aqua citing exorbitant prices, frequent rate increases and poor communication and service; and

WHEREAS, these County residents have no other alternative to procure these essential services and struggle to keep pace with ever increasing bills and fees imposed by Aqua; and

WHEREAS, Virginia Senate Bill 85, patroned by Sen. Thomas A. Garrett, Jr., has been approved by the Senate and is now before the House during the 2016 Virginia Assembly session; and

WHEREAS, the bill requires the SCC to make information relating to (i) salaries and other remuneration paid by a public utility to its executive officers, (ii) payments or transfers by a public utility to its parent corporation, and (iii) the content of communications between the employees of the SCC and representatives of public utility companies open to inspection and copying by any citizen of the Commonwealth and provides several other provisions designed to protect the interests of corporate utility consumers; and

WHEREAS, the bill will benefit Aqua customers in Northumberland County and corporate utility customers throughout the Commonwealth.

NOW THEREFORE BE IT RESOLVED, that the Northumberland County Board of Supervisors hereby declares its strong support for Senate Bill 85 and urges the bill's passage in the 2016 Virginia General Assembly session.
