7. Public Comments

Mrs. Lynn Stuart thanked County Attorney Gregory for his clarification on the Code of Virginia that she cited at last month's meeting and appreciates his sentiment of requesting expenditure information from her district school board representative. Mrs. Stuart stated that she has continued her research in school boards and gave some statistical information regarding Fairfax County school district, who is relatively close to our composite index here in Northumberland County.

Mr. Patrick O'Brien expressed his concern with the school board's budget. Mr. O'Brien stated that the school board must provide the Board of Supervisors with any information they request, and if they fail to do so the Board of Supervisors has the right to subpoend that information.

Ms. Karen Cridlin came to the Board in representation of a group of 29 homeowners with property in Chesapeake Bay Estates and along Chesapeake Beach Road fronting the Bay. Ms.

Cridlin is requesting approval from the Board to allow Northumberland County to apply for a grant that would provide funding for a study on the protection of the shoreland in the County. This group of 29 homeowners have long been concerned about increased storm surges, property damage, and land erosion, so their goal is to identify evolving methods to address these issues. Ms. Cridlin expressed that these homeowners need the Board's representation and if no action is taken, this area and others around the Chesapeake Bay region are on a path of substantial loss.

James Michel expressed his appreciation to County Attorney Gregory for getting that information to the public on the Code of Virginia regarding the school's budget presentation. Mr. Michel advised the Board to be more specific when requesting information from the school, specifically regarding the budget.

Zoning Administrator Philip Marston ensured Mr. Jackson that Social Services, as well as the Building Official, are working to come up with a solution involving the conditions both inside and outside the house.
