Discussion: C. Callao Project Update

Mrs. Lisa Deitz came to the Board in representation of the Callao Hometown Community Association (CHCA). Mrs. Deitz gave a brief overview on CHCA:

CHCA was formed as a non-profit organization as part of the County's revitalization grant from the Virginia Department of Housing and Community Development. CHCA was initiated to promote Callao and the revitalization activities to provide the ongoing growth of Callao to foster business, development, expansion, etc. The original revitalization plan included a park for our community, but numerous factors did not allow for this inclusion in the program under the grant application, however community members recognized the need for a park and continued to seek land by pursing options in the center of Callao.

Mrs. Deitz announced that CHCA was here tonight to officially inform the Board that Monday June 13, 2022, the final papers were signed, and ownership was transferred for approximately 2.3 acres to CHCA thanks to the generous gift from Bobby Burgess and his family. Mrs. Deitz shared a plat with the board of where the park is going to be located.

Mr. Bobby Burgess came to the Board and spoke on how good the County has been to him and his family. Mr. Burgess saw the benefit of granting his land to CHCA and hopes the Supervisors support the efforts of making this park a reality for the community.

All Board members expressed their appreciation to Mr. Burgess for his efforts and generosity related to the park as well as thanked him for all his contributions to the County over the years.

Supervisor Tomlin asked if there are any grants that the County can seek in relation to this project.

County Administrator Tadlock stated that he wasn't sure but it's something to look into.

8. Budget Work Session

Action, Information: A. Hazardous Duty Resolution

County Administrator Tadlock referenced discussion on the VRS enhanced hazardous duty benefits for the EMS employees at the meeting on June 7, 2022. Mr. Tadlock stated that if the Board wishes to include this in the upcoming budget, he requests them move forward with the approval of the resolution, so it allows staff to complete the necessary operations by the end of the fiscal year.

Supervisor Tomlin asked if the Sheriff's Office has been covered under hazardous duty previously.

County Administrator Tadlock and Sheriff Beauchamp confirmed that the Sheriff's Office has been covered under hazardous duty for quite a while.

Motion to approve the VRS enhanced hazardous duty benefits resolution for the EMS employees using the 1.70 multiplier.

The resolution is as follows:

Enhanced Hazardous Duty Benefits

WHEREAS, subject to the approval of the Virginia Retirement System ("VRS") Board of Trustees, Code of Virginia § 51.1-138 permits a political subdivision of the Commonwealth of Virginia currently participating in VRS to make an irrevocable election to provide enhanced hazardous duty retirement benefits for its eligible employees as outlined in § 51.1-138; and

NOW, THEREFORE, BE IT RESOLVED, that the [insert Locality or Other Political
Subdivision Name]Northumberland County (the "Employer") does hereby elect to
have such employees of Employer who are employed in positions as full time [circle all that
apply] Law Enforcement Officers (Firefighters) Emergency Medical Technicians Jail Officers
and whose tenure is not restricted as to temporary or provisional appointment, become eligible,
effective the first day of [insert month and year], for VRS
benefits equivalent to those provided for state police officers of the Department of State Police,
as set out in § 51.1-138 including the retirement multiplier of [circle elected multiplier (1.70%) or
1.85%, in lieu of the benefits that would otherwise be provided to such employees, and Employer
agrees to pay the employer cost for providing such benefits; and

NOW, THEREFORE, the officers of Employer are hereby authorized and directed in the name of Employer to carry out the provisions of this resolution and to pay to the Treasurer of Virginia from time to time such sums as are due to be paid by Employer for this purpose.

Discussion: B. Budget Discussion

County Administrator Tadlock stated that during the budget work session held on June 7, 2022, there were some additional questions in relation to the school buses. Staff reached out to the School Board and received some information, which was provided in the Board's packet. Some additional information related to the Sheriff's Office vehicle request was also provided in the Board's packet.

County Administrator Tadlock checked with the Treasurer and provided the medic unit emergency billing funds amount which was approximately \$318,648. Currently, the County has

a second ambulance that is almost ready that costs \$213,000, leaving an amount of \$105,000 remaining in that account.

Supervisor Tomlin asked if the EMS funds stated are from the beginning of last year or current figures.

County Administrator Tadlock stated that these are current figures.

County Administrator Tadlock also addressed a question made related to ARPA funding. Mr. Tadlock informed the Board that last year the County received \$1,174,656.00 and are waiting to receive the second round of funds of \$1,174,656.00. Total obligations to date are approximately \$1,122,399.38 and provided was documentation of the projects the County is looking at, totaling \$948,361.39. This would leave approximately \$278,551.23 remaining in ARPA funds.

Lastly, County Administrator Tadlock discussed different options with the Treasurer as well as the Commissioner of Revenue on what the best approach is to offset the recent appreciation in the values of vehicles. A considerable option was reducing the assessment ratio from 40% to 35%.

Supervisor Tomlin asked what the 5% reduction meant in terms of less personal property vehicles being brought in.

County Administrator Tadlock stated that this adjustment would bring in the amount they were anticipating because of the appreciation in the values of the vehicles.

Supervisor Tomlin asked if any other localities nearby have been taking any action on this.

County Administrator Tadlock informed the Board that a lot of localities are looking at different ways, one being this option and the other is modifying the personal property tax relief percentage.
