Board of Supervisors Budget Work Session (Tuesday, June 7, 2022)

The meeting was convened as a special meeting called by Chairman Haynie and held at the Northumberland Courthouse located at 220 Judicial Place, Heathsville, VA 22473.

1. Opening of Meeting 5:30 P.M.

Action, Discussion, Information: A. Budget Work Session

Chairman Haynie turned the discussion over to County Administrator Tadlock to discuss some information related to the budget.

County Administrator Luttrell Tadlock announced that the County held the budget public hearing on June 2, 2022, but by the Code of Virginia, the Board cannot take action for seven days, therefore this meeting on June 7, 2022, is just a work session.

County Administrator Tadlock provided information to the Board on some potential reductions and asked if they had any specific questions on those, or if they would like to go through those items at this time.

Supervisor Long suggested to go through the potential reductions.

County Administrator Tadlock presented some possible reductions to the Board as follows:

County Administrator Tadlock informed the Board if they wished to move forward with the Emergency Services hazardous duty, there is a resolution required to be adopted no later than the middle of June, so information can be provided to VRS in time to make adjustments for July 1, 2022.

Supervisor Tomlin asked if that calculation was on the total County employees, not just EMS employees.

County Administrator Tadlock confirmed the calculation is on the total employee population of the County.

County Administrator Tadlock stated that other localities have been looking at these impacts and approving to move forward with the hazardous duty.

Supervisor Tomlin asked Mr. Tadlock what other counties have approved the Emergency Services hazardous duty.

Supervisor Brann informed the Board that King & Queen, Essex, Westmoreland, and Richmond County have already approved this, and Lancaster is looking to approve it.

Supervisor Brann suggested the Board look into the hazardous duty and consider it. Mr. Brann acknowledged that the Board has set aside funds for the revenue recovery to help purchase equipment and asked if there was a way to use a portion of these funds that are set aside to help fund the hazardous duty. Along with this, Supervisor Brann noticed that overtime for EMS was reduced, so he questioned using that difference to offset the hazardous duty cost as well.

County Administrator Tadlock believed that this was something staff could look into to see what exact funds are set aside in revenue recovery.

Vice Chairman Jett referenced where the revenues are shown and asked County Administrator Tadlock if the EMS generated funds are included in that figure.

County Administrator Tadlock confirmed that the EMS Billing monies are shown on the revenue side of the budget.

County Administrator Tadlock informed the Board that he could get the EMS billing money information for the Board by Thursday's meeting, June 9, 2022.

County Administrator Tadlock explained that the other possible reduction the Board could look at is removing or delaying any of the capital improvement projects. The County held a public hearing on the capital improvement plan on June 2, 2022, and the plan was approved, but no approval on any appropriation of monies took place.

Supervisor Brann wanted confirmation that the reductions for the Food Bank, Free Health Clinic, Little League, and the Boys and Girls Club would still allow them level funding from last year.

County Administrator Tadlock informed the Board that all agencies would be level funded with the reductions except the Boys and Girls club, which we do not currently fund.

Supervisor Tomlin asked if Mr. Tadlock had any idea of what capital improvement projects could possibly be delayed.

County Administrator Tadlock wasn't sure of this but suggested the reduction of vehicles or looking into additional grants to help pay for the well replacement at the school.

Chairman Haynie asked Mr. Tadlock to receive some further information from the Sheriff on his vehicle request.

Supervisor Long asked how many buses the school is requesting.

Assistant County Administrator Basye informed the Board that the school originally requested 2 regular sized buses and one special education bus, but the committee approved two buses of the school's choice at a cost of \$100,000 each.

Vice Chairman Jett asked if the capital improvement funds were in the budget.

County Administrator Tadlock informed the Board that currently in the budget under CIP are:

Sheriff's Office, Vehicles - \$250,000

School Division, Well Replacement - \$110,000

School Division, Buses - \$200,000

School Division, Bus Garage Roof - \$100,000

County Administration, Building Maintenance - \$150,000

The request from the Sanitation District of a generator at Reedville Pump Station & Post Office pump upgrade are not in the budget because we can use ARPA funds for this project.

Supervisor Tomlin asked if the generator is paid for using ARPA funds, how much money would remain in those funds.

County Administrator Tadlock stated that he would look into that and forward that information to the Board.

County Administrator Tadlock suggested the Board schedule another budget work session at this Thursday's regular meeting, June 9, 2022 during the public hearing session at 7:00 p.m.
