6. Where is the recycling currently transported to and processed? **Currently being transported to the Riteway Recycling (4049 Northumberland Hwy., Heathsville VA 22473).**
7. Do you have any data on the composition of the recycling stream? **We do not have any specific data on the composition; however, recycling containers include paper, plastic, cardboard, glass, metal and oil.**
8. Would the county consider handling the convenience site staffing and only soliciting rates for the compactors, containers, hauling, and disposal? **The County is seeking a vendor for the full service including that of staffing. An option that would be considered is separating the solid waste and recycling contracts to different vendors. However, the current situation is that the solid waste is separate from the recycle vendor and the solid waste vendor staff is monitoring the recycling bins.**

9. Would you like the compactors to mirror the current setup Waste Management has onsite? **Yes**
10. Also for the 30 yard Open tops at each location, I see there isn't a designated number required. In your opinion is the current 3 open tops at each site sufficient? **For the winter months yes, typically on major holidays and sometimes during the summer months additional open top containers are needed to accommodate the additional trash.**
11. For labor and truck allocation purposes, do you have an estimated haul frequency for the compactors and open tops? **Please see question # 2 above.**
12. I see there is mention of mixed use recycling, but nothing specifying the amount of cans needed for each site. Would you be able to provide that for me? **There will need to be 2 compartmentalized containers at each site (six (6) total compartmentalized containers). There needs to be one (1) open top container for metal recycling at each site (three (3) total open tops for metal. There needs to be three (3) 500 gallon oil drum recycle containers (two (2) are to be located at Horsehead, and one (1) is to be located at Ditchley). Please provide an option for one- 500 gallon oil recycle drum at each of the solid waste locations.**
13. Are the sites single phase electricity or 3 phase electricity? **All three sites have 3 phase electricity.**
14. Once provided the frequency of pulls, are you looking for an all inclusive price? Or would we be invoicing monthly based on the number of pulls completed each month? **We would be looking for monthly invoices based on the number of pulls/tonnage completed each month for each site. The pull/tonnage rates shall be fixed on annual basis and would be negotiated at the beginning of the contract period.**
