Pre-Meeting: All required materials – unused blank ballots, scanned ballots, v-Drives, and reports envelopes – were delivered to the Northumberland Clerk of Courts at 11:25AM as required per code.

Precinct Review: (6/18/25)

- Central Absentee: Mailed All Absentee ballots (121) submitted up to poll closing on Election Day were Pre-Processed per schedule. There were no errors in processing with tapes, Statement of Results, and reports completed, signed, & filed properly. The CAP team met on Friday, 6/20 at Noon to complete final processing of any late arriving (Noon deadline) mailed-in Absentee Ballots.
- Provisional Ballots cast: There were no Same Day Registrations nor Provisional Ballots in the entire jurisdiction for this election.
- ❖ EARLY In Person Voting: Canvass showed a total of 176 ballots were cast, The Ballot On Demand (BOD) machine was utilized to generate individual ballots for the voter's respective precinct. A scanner failure (feeding issue) was encountered after 120 ballots were scanned. The officials on site quickly brought the "spare" scanner into use. As such, EV generated two sets of closing tapes, sum total of each being combined for final SOR. There were no errors in processing tapes, Statement of Results, and all reports completed, signed & filed properly.
- .2nd Precinct Heathsville: Canvass showed 81 ballots were cast on Election Day, There were no errors in processing found with tapes, Tapes and reports completed correctly, except as noted below.
 - (1) Deficiencies Found: While the Yellow Return Sheet was properly signed & submitted, the required two Statement of Results forms were not as required. An incorrect, outdated SOR was used and no tapes were attached – all corrected by Board, (2) The included proper Ballot Record Report was not used. In its place the Election Officer used a Ballot Tracking worksheet to record the needed information, which did reflect balanced accounting. The Board manually transposed the correct data onto the correct BRR.
- Precinct 3 Burgess: Canvass showed a total of 90 ballots cast on Election Day. There were no errors in processing all tapes, Statement of Results, with reports completed, signed & filed properly. There was a minor error in completion of BRR, which the Board easily corrected. However, of considerable significance, both Poll Pads were improperly

EB Minutes, 6/23/2024 Canvass Meeting page 2 placed (upside down) in their respective carrying cases at end of day. This resulted in damage to one iPad tablet interfering with extraction of proper uploading of data into the required software. The EB and GR were successful in re-constructing and matching turnout.

- Precinct 4 Wicomico Church: Canvass showed a total of 74 ballots were cast on Election Day. There were no errors in processing machine tapes, and Statement of Results, with reports completed, signed & filed properly. The only discrepancy found was the failure to remove rings from the reserve paper poll book.
- Precinct 5 Reedville: Canvass showed a total of 81 ballots cast on Election Day, There were no errors in processing found, with all tapes, Statement of Results, and reports completed, signed & filed properly. The discrepancies found were the failure to remove rings from the reserve paper poll book, the insertion of two returned absentee ballots in the wrong place and a minor mathematical error in voter check-ins on the SOR. Each was corrected by the Board.

Suspension of Canvass: (6/18 at 3:50 PM) With all available information at this time was processed, the meeting was suspended and will re-convene at Noon on Friday, June 20 for finalization with late arriving (PE) absentee ballots and completion of Abstracts and Certification.

Resumption - (Friday, 6/20 Noon) <u>NOTE</u>: Electric power to the GR office was lost to a storm the prior evening, and out all day. Following the completion by the CAP team's processing of late arriving ballots, the Canvass meeting re-convened at 1:20 PM to record late arriving mailed ballots and preparation of Abstracts and final certification. All was satisfactory. Due to the power outage, finalization of CAP results, election certification, and preparation of abstracts could not be completed. This Canvas Meeting was suspended until Monday 6/23.

Resumption – (Monday, 6/23 at 10:00AM) The Vice Chair and Secretary attended (Chair absent due to a prior planned vacation) for the purpose of Certifying and Abstract preparation.

- Final error validation was satisfactorily completed.
- Four sets of Abstracts were generated, properly Sealed with the Electoral Board seal, and signed as required.
- All abstracts were distributed as appropriate, with copies attached hereto.
